Spend a night in Las Vegas on the fashionable strip; explore Utah's canyonlands and red rocks on an open air tram tour through Zion National Park. See the famed "Pink Cliffs" of Bryce Canyon National Park and venture into Dead Horse Point State Park with its amazing views of the Colorado River and massive sandstone walls. Tour the Arches National Park to see the largest concentration of stone arches in the world. Travel aboard one of the top 10 rail adventures in North America and the internationally recognized Rocky Mountaineer Train. Experience "Silver-Leaf-Class-Service" on board the Rocky Mountaineer as we travel the rails from Moab to the resort town of Glenwood Springs, Colorado. Then, enjoy another day of "riding the rails in luxury" as we follow the Colorado River passing beautiful red rock formations, desert cliffs and canyons on our way to Denver, Colorado! Join us for a once in a life time adventure!

Day 1 Monday, September 19, 2022- Las Vegas

Our flight arrives at the Las Vegas International Airport and a transfer to our Casino Resort Hotel located on the world-famous Las Vegas Strip. After settling in, join our fellow passengers for a **welcome dinner** at a local restaurant. The rest of the evening is free to explore and enjoy all that Las Vegas has to offer.

Day 2 Tuesday, September 20, 2022 – Zion – Bryce Canyon

Today we depart Las Vegas and travel across the Nevada Dessert with a rest stop along the way. Then enter Utah's oldest and most famous national park, **Zion National Park**. Experience the massive 2,000-foot high formations and towers in the park, Zion Canyon with its lush green canyons and the Virgin River flowing against a backdrop of huge red rock cliffs. It is no wonder the local Paiute Indians believed it was a place that the spirits dwelt and would not enter after dark. Later in the afternoon, we travel along the Mt. Carmel Highway through the Zion Tunnel on our way to Bryce Canyon for overnight. This evening we enjoy a wonderful western food and entertainment at **Ebenezer's Barn and Grill**.

Day 3 Wednesday, September 21, 2022 – Bryce Canyon – Dead Horse Point - Moab

This morning enter **Bryce Canyon National Park** for sightseeing. The vibrant colors and unearthly shapes of Bryce Canyon spark the imagination of both young and old. The Paiute Indians described the canyon as "red rocks standing like men in a bowl-shaped canyon." Pioneer and settler Ebenezer Bryce, for whom the canyon was named, described it as "a hell of a place to lose a cow." Next enjoy a drive on one of America's most spectacular roads, Scenic Highway 12, designated as an "All American Road," the crown jewel of the Scenic Byways system. Travel through Grand Staircase – **Escalante National Monument**, with vast expanses of cream and rose colored Navajo sandstone. There are dramatic cliffs, high mesas, beautiful streams and deep canyons in multi-hued colors across this 1.9 million acre monument. Drive up and over **Boulder Mountain** reaching altitudes over 9,000 feet with incredible views of **Capitol Reef**, the **Circle Cliffs** and the **Henry Mountains**. We arrive at **Capitol Reef National Park** for a **picnic lunch** under old growth cottonwood trees. This park features petroglyphs, beautiful rock formations, deep canyons and pioneer history. In the afternoon, travel through the San Rafael Swell and the town of Green River and on your way to **Dead Horse Point State Park** for one of the most spectacular scenes in the southwest. You will see the expanse of **Canyonlands National Park** stretching to the south and the mighty Colorado River 2,000 feet below. Then arrive in **Moab** and check in for overnight. The evening is free to explore and have dinner on your own.

Day 4 Thursday, September 22, 2022 – Arches –Rocky Mountaineer

This morning we are off to nearby **Arches National Park** for touring. The unique geology of the area created the highest concentration of natural arches in the world with over 2,000 named arches within the park boundary. We will visit the park's highlights including **Balance Rock, The Windows and Delicate Arch Viewpoint**. Upon our return to Moab, enjoy some free time for lunch (on own) and to explore this fun town. In the afternoon, board the famed **Rocky Mountaineer in Silver Leaf Class** and begin the journey eastward. Enjoy award winning service and informative narrations by our rail conductor as our scenic rail adventure begins! We depart Moab and travel through Colorado Canyons National Conservation Area. See Parachute Creek and Mount Logan while following the scenic Colorado River and taking in beautiful red rock formations, desert cliffs of Ruby Canyon and mountain vistas.

Day 5 Friday, September 23, 2022 – Rocky Mountaineer - Denver

Enjoy a full day “*riding the rails in luxury*” aboard the Rocky Mountaineer. Experience the breathtaking views from the comfort of your spacious, reclining seats and through the train’s oversized glass windows. The onboard culinary experience highlights cuisine and ingredients local to the Southwestern U.S. From the dense wooded forests and white-capped mountains of White River National Forest, to picturesque Byers and Gore Canyons and the raging rivers, tranquil mountain lakes of Arapahoe National Forest, this journey is a special adventure! Cross the Continental Divide with a sparkling wine toast while cutting through the six-mile-long Moffatt Tunnel. Upon arrival, we transfer to our downtown hotel with the rest of the evening free to explore Denver on our own. The 16th Street Pedestrian Mall as well as the Union Station area in the “Lo-Do” district which offers the visitor wonderful shops and restaurants all within walking distance of our hotel.

With elevations ranging from 8,000 feet on the wet, grassy valleys to 14,259 feet at the weather-ravaged top of Longs Peak, the park is filled with breathtaking scenery and experiences. Following the **Trail Ridge Road** a stop at the **Alpine Visitor Center** offers an opportunity to learn more about this fascinating place. *(Please Note: access to Trail Ridge Road may be limited due to weather in late September). We then return to Denver for a tour of the city highlights. Tonight, enjoy a **farewell dinner** at the historic **Buckhorn Exchange**.
